#### **WINTER CLOSING SCHEDULE:**

**MON OCTOBER 17<sup>TH</sup>** - LAST DAY FOR SEPTIC FLUSH OUTS AND REGULAR PUMPOUTS

**TUES OCTOBER 18<sup>TH</sup>** - WATER IS TURNED OFF TO THE PARK AT 8:30 AM

**WED OCTOBER 19<sup>TH</sup>** - LAST DAY FOR ALL SERVICES SUCH AS TRASH PICKUP, LEAVES.

**AFTER OCT 19<sup>TH</sup>** - DUMPSTERS WILL BE LOCATED AT THE POLE BARN.

**PLEASE DO NOT PLACE TRASH ON SCRAP TRIALER.**

THE GREY BATHHOUSE WILL REMAIN OPEN AFTER WATER IS TURNED OFF IN THE PARK. YOU WILL BE ABLE TO GET WATER, TAKE SHOWERS, AND HAVE USE OF THE RESTROOMS.

#### **REMINDERS**

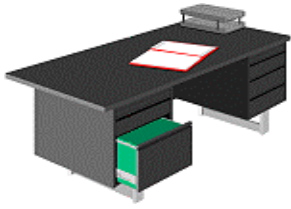

## FROM THE DESK OF THE OFFICE MANAGER

Happy Autumn Everyone

Wrapping up another 'fast gone by summer' is upon us. Hope everyone had a good season and was able to enjoy some time up here.

Here is my "closing the season" schedule for you---  
-

Sept. 18<sup>th</sup> - doing 3rd reading of the meter readings rotation. (Lots 289-378).

Oct. 23<sup>rd</sup> - Final 2011 season meter reading for the whole campground.

There will not be another reading until May of 2012.

(If a "final" 2011 electric invoice is issued, it will show up on the Maintenance Statement. This will be sent out the end of Nov. and will be due upon receipt.)

Nov. 1<sup>st</sup> - 15<sup>th</sup> - vacation

Nov. 16<sup>th</sup> - 23<sup>rd</sup> - invoicing

Nov. 27<sup>th</sup> - 30<sup>th</sup> - mailing out statements to everyone showing all transactions for 2011 and 2012 invoices due.

**All electric is due upon receipt.**

**Maintenance, storage, snow plowing etc. is due January 1st, 2012**

**Please send any 2011 and 2012 payments on separate checks for bookkeeping purposes. 2011 and 2012 payments are applied to different budgets and different accounts.**

If you wish to send in installments for the 2012 fees you may do so. But the full amount is due

Jan. 1, 2012. If you send in installments prior to January 1st, make a notation on the memo line of the check. Any payment received after January 1<sup>st</sup> is considered delinquent.

I am asking that everyone fill out a customer contact sheet annually. I am still finding emails, phone numbers, cell numbers and emergency contacts are not current for everyone. I have some lot owners that do not have anything showing in the computer but an address. Emails and phone numbers are very important for management to contact you in case of emergencies. (I do keep them confidential) I will be including an annual sheet with the end of the year statements, PLEASE fill it out and return with payments. OR email information to [cscampground@gmail.com](mailto:cscampground@gmail.com). By emailing it reassures me a GOOD e-mail address when received.

Please send all payments in promptly. We all understand that the economy is tough right now. But you have to understand that the campground has monthly bills due also. Your money is what pays the campgrounds bills. Our budget is prepared with intentions that all invoices are paid upon receipt. (Just a reminder -- if you become delinquent on your payment, finance charges are applied on the 15th of each month.) So, please send payment to avoid additional cost.

I will be putting something on the website early in the New Year with information about the "3rd Annual Bonfire". Our annual intentions aim for the last Saturday in January (weather permitting). But keep an eye on the website for information and details.

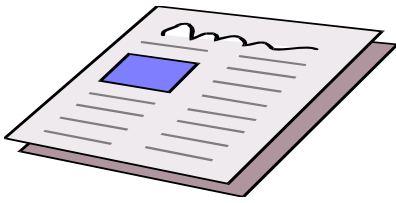
